The driver should undertake a walkaround of the vehicle prior to every journey. Legal minimum standards must maintained such as tyre depth, operational mirrors and vehicle body condition. The driver is responsible for ensuring the vehicle is not overloaded. The driver is repsonsible for ensuring any items on a roof rack are secured to the roof rack adequately.
